## **Vote with the League on propositions on June 8 ballot**

**F**ive state propositions appear on the June 8 election. A proposition becomes law if it gets more than 50 percent "Yes" votes. Propositions 13, 14, and 15 were placed on the ballot by the State Legislature. Propositions 16 and 17 are initiatives placed on the ballot because supporters collected enough signatures. The last day to register to vote in this election is May 24. Due to space

**Proposition 13** Limits on Property Tax Assessment. Seismic Retrofitting of Existing Buildings

Currently taxes owed on a property are based on its "assessed value" which is set as the amount paid at purchase. Prop 13 passed in 1978 placed a 2% limit on how much a property's assessed value can increase each year after that. A property gets a new assessed value when the property is sold. It may also be reassessed if it undergoes construction for improvements. Amendments to Prop 13 have created exclusions from the requirement to reassess a property's value after construction upgrades. Two of these exclusions deal with earthquake safety upgrades. This Proposition would combine the exclusions related to earthquake safety into one. The result would be that earthquake safety improvements on any property would not trigger a reassessment until the property is sold. **The League has NO recommendation.**

**Proposition 14** Primary Elections. Increases the Right to Participate in Primary Elections.

Currently California voters elect state and federal officials with a two-step process; 1) primary elections in June with each party selecting a candidate for each office; 2) general election in November in which voters choose between the winning candidates from the primary, one from each party. All voters get the same ballot in November. In the primary, voters registered with a party get a ballot with their party's candidates. Decline to state voters get a ballot with only nonpartisan officers. Some political parties allow independent voters to ask for their party's ballot in the primary; others do not. Prop 14 would change the State Constitution to start a new election process for statewide offices plus congressional and legislative representatives. For the primary, all voters would get the same ballot listing all candidates. The general election ballot would contain only the top two candidates who got the most votes for each office in the primary, even if they are in the same party. **The League has no recommendation.**

**Proposition 15** California Fair Election Act, Public Funding of Campaigns

Currently state laws ban the use of public funds for campaigns for elected office. Candidates need to raise funds to pay for their campaigns. The main job of the California Secretary of State is to oversee elections. It also reviews the activities of lobbyists. Prop 15 would lift the ban on public funding for political campaigns and set up a temporary program to test public campaign funding just for candidates for Secretary of State in the 2014 and 2018 elections. Candidates who choose to participate in the test of public campaign funding must agree to spending limits and other guidelines. It would help reduce the influence of political donors. **The League SUPPORTS this proposition.**

**Proposition 16** Local Public Electricity

Presently most Californians get their electricity through corporate utilities such as PG&E. Cities and counties, separately or together, can choose to form their own electric service or they may contract for it with a provider other than a corporate utility. A local government's decision to contract for electricity services does not need voter approval. If service from an existing publicly owned utility is to be expanded into a new area, voters in the existing service area do not usually need to approve the expansion. Prop 16 would require two-thirds of voters to approve their local government's use of public funds to start up or contract for electric service or to expand service to new areas. Prop 16 has a few exceptions, such as when electric service is provided by wind or solar or if local government is the service's only customer. Passage would make it more difficult for local governments to get into the uncertain retail electricity business. **The League OPPOSES this super-majority vote requirement.**

**Proposition 17** Auto Insurance Pricing

Currently, Prop 103, passed in 1988, set up rules about rates insurance companies can charge. For auto insurance, rates are based mostly on a driver's safety record, the number of miles driven each year, and the number of years a person has been driving. Insurance companies are not allowed to use gaps in auto insurance coverage as a factor in setting rates. Prop 17 would allow insurance companies to include whether someone has had continuous auto insurance coverage as part of how they set rates. The discount for continuous coverage could be offered to someone who did not let his or her insurance lapse for more than 90 days in the past 5 years. Insurance companies may also be able to increase rates for drivers who did not qualify for this new discount. Insurance companies would still be required to base rates on Prop 103

guidelines but this adds an additional discount that could be offered. **The League has NO recommendation.**
